-Renee Hafer reported that PTA covers the free lunches that students need since DMA doesn't get government assistance. Around 197 Cadets were eligible last year. This amounted to 1,450 free lunches with a cost to PTA of \$3,920. It is projected that we may have 200 students needing free lunch this year. Volunteers are always needed to help serve the students.

Hospitality- Hilary Raptis explained that most events no volunteers are needed. She may need help if she has a conflict. Some donations will be needed but most snacks and/or cake are bought using PTA money. The first event will be the Back to School Night on August 28th 5:00-7:00. There will be several events towards the end of September.

Membership- Daniele Wenzel (New and not at the meeting.) We will work on increasing membership during the back to school night.

It was noted that we currently have 25 PTA members as of the meeting. Normally we have 100% of teachers join.
